
**Thailand Arbitration Center Rules
on the Arbitrator Committee (No. 2)
2017**

Whereas it is expedient to revise the Rules of the Thailand Arbitration Center on the Arbitrator Committee B.E. 2558 (2015) for the sake of the efficiency of the Arbitration Committee.

By virtue of Section 18 (5) of the Arbitration Center Act B.E.

Article 1 These Rules are called “Rules of the Thailand Arbitration Center on the Arbitrator Committee (No. 2) B.E. 2560”.

Article 2 These Rules shall come into force from the day following the date of its publication in the Government Gazette.

Article 3 The following shall be added as Article 5/1 of the Thailand Arbitration Center Rules on the Arbitrator Committees of 2015

“Clause 5/1 The committee may convene by means of video conference or telephone. (Teleconference) or through other forms of electronic media.”

**Thailand Arbitration Center Rules
on the Arbitrator Committee
B.E. 2558 (2015)**

Whereas it is expedient to have rules relating to the arbitrator committee as a guideline for the appointment and retirement of their position and the operation of the arbitrator committee. The Thailand Arbitration Center, therefore, prepares the Rules of the Thailand Arbitration Center on the Arbitrator Committee as follows:

- Article 1 There shall be a committee called the Arbitrator Committee, consisting of not more than 15 members appointed by the Board of Directors of Thailand Arbitration Center. The Board of Directors will appoint a Director as the Chairman and another Director as the Vice-Chairman. To be appointed, the Chairman and the Vice-Chairman must be qualified practitioners who have the knowledge, ability, and/or experience in the arbitration field for not less than 10 years. To be appointed, the other members must be qualified practitioners who have the knowledge, ability, and/or experience in the arbitration field for not less than 5 years.
- Article 2 The Arbitrator Committee shall hold office for a term of 3 years. All the members may be reappointed. At the expiration of the term under paragraph one, if a new Arbitrator Committee has not yet been appointed, the vacating committee shall perform duties for the time being until a new committee is appointed.
- Article 3 In addition to vacating office before the expiration of the term in Article 4, a committee member vacates office upon:
- (1) die
 - (2) resignation
 - (3) dismissal by the Board of Directors of Thailand Arbitration Center due to negligence in the performance of duties, failure to

perform the duties as scheduled consecutively without reasonable cause, having disgraceful behavior, or incompetence.

Article 4 In the event that a member of the Arbitrator Committee vacates office before the expiration of the term, the Arbitrator Committee may appoint another member to act on their behalf.

Article 5 In the meeting of the Arbitrator Committee, there must be at least half of the directors attending the meeting. All appointed members shall constitute a quorum.

If the Chairperson and the Vice Chairperson are not present at the meeting or are unable to perform their duties, the members present at the meeting shall elect one among themselves to preside over the meeting.

The resolutions of the Arbitrator Committee shall be made by a majority of votes. Each member shall have one vote. If the votes are equal, the chairman of the meeting shall have one more vote which is considered as the decisive vote.

Clause 6 In the performance of the powers and duties of the Chairman, if there is no chairman or the chairman cannot perform his/her duties. The Vice Chairperson or Director of the Arbitration Institute shall act. Responsibilities in order

Clause 7 The members are prohibited from performing their duties or attending meetings in cases or matters in which they have interests or have grounds to cause them to lose their neutrality.

Article 8 The Chairman, the Vice-Chairman, and the members of the Arbitrator Committee receive remuneration for performing their duties, as prescribed by the Board of Directors.
