SUMMARY OF SPECIALISATION

As a Chartered Quantity Surveyor and Chartered Construction Manager with over twenty years of experience in the construction and infrastructure industries, I specialise in dispute resolution, quantum analysis, expert witness services, construction claims analysis, contract management and the provision of facilitative and determinative dispute resolution services. I am experienced in all stages of the project lifecycle on a wide range of projects including the resolution of contentious and non-contentious issues involving quantum, delay, contract and technical matters involving loss and expense, disputed variations, extension of time, liquidated damages and defective work type claims.
