He was managing partner of DLA Piper's Bangkok office from 2006 to 2021. From 2021 to April 2024 he was a Senior Consultant to DLA Piper. He is now an independent consultant and arbitrator.

His principal areas of practice have been commercial litigation and arbitration with an emphasis on insurance, reinsurance and construction. He also advised the insurance industry generally on investment into Thailand and on various insurance regulatory issues.
